China and Construction Industry Training Authority (CITA). The Training Scheme was intended to sharpen the construction management knowledge and practice of those P.R. China construction officials and professionals from Beijing and other provinces of Mainland China so as to enhance the construction management system in the P.R. China to match with the internationally recognized standard, which was especially crucial upon its joining of the W.T.O. Mr. Ng also acts an active assessor in the Assessment of Professional Competence (APC) of the Hong Kong Institute of Surveyors (HKIS) and Hong Kong Institute of Construction Managers (HKICM). He is also registered as the approved professional interview assessment chairman / assessors in the professional interview panels of the Chartered Institute of Building (CIOB-HK) and the Hong Kong Institution of Engineers (HKIE).

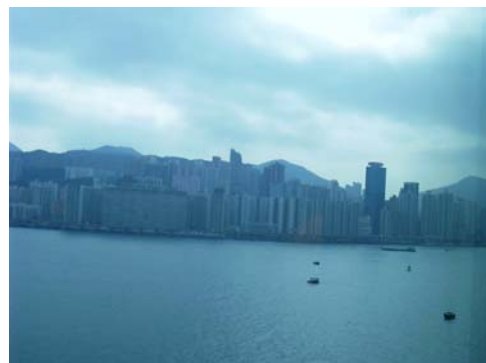
